## GSI'S NEW WEBSITE OFFERS EASILY ACCESSIBLE RESOURCES


We've frequently heard from policymakers and citizens alike how difficult it is to find impartial analysis and data sources on the health of New Jersey's economy, fiscal health and public services.

## PUBLIC SAFETY SETS THE STAGE FOR ECONOMIC PROSPERITY

With a recognition that economic prosperity begins with public safety, in October 2021, GSI sponsored, in partnership with the NI Urban Mayors' and Sheriffs' associations, a forum in Paterson with former NYPD Commissioner and LAPD Chief Bill Bratton to address violence from illegal guns in our cities and to recommend adjustments to New Jersey's 2017 bail reform in order to increase the authority of prosecutors and judges to keep illegal gun defendants remanded while awaiting trial.


That forum led to bipartisan legislation (A2426/S513)

that was introduced in the legislature in early February and ultimately passed both houses by overwhelming margins and was signed into law by Gov. Phil Murphy on June 30 this of this year.

# MAKING GOVERNMENT WORK FOR OUR VETERANS



A report from GSI and New Jersey State Veterans Chamber of Commerce (NJSVCC) uncovered that the State of New Jersey is failing to meet the requirements of a 2015 state law that sets aside a percentage of state procurement contracts for veteran owned businesses. The report was featured statewide in an exclusive in the USA Today Network.


Since 2015, New Jersey has had a public law that sets aside 3% of its state contracting agencies' budgets for Disabled Veteran Owned Businesses. However, according to research by the New Jersey State Veterans Chamber of Commerce, of the 72 state agencies that have procurement power, a mere few have awarded contracts to disabled veteran owned businesses, only two of 72 are enforcing the law and none are reporting their numbers as legally required.

Beyond those revelations, the report, which was authored by Col. Jeff Cantor (U.S. Army, Ret.), founder and CEO of the NJSVCC and Col. Paul B. Olsen (U.S. Army, Ret.), former Lead Speechwriter to Gen. David Petreaus, offers a vision for New Jersey to improve its support of veteran owned businesses through a series of strategic initiatives.

The report's vision challenges our state government to ensure that New Jersey will join the top 25% of the best states for supporting veteran owned businesses as defined by the Small Business Administration and meet or exceed the requirements of its 3% state mandated Disabled Veteran Owned Business law.

## NJ'S DEATH TAX HINDERS AFFORDABILITY & COMPETITIVE STANDING



When New Jerseyans complete their annual tax filings, many were reminded of an unfortunate reality the Garden State remains one of just six states to collect a Death Tax, or tax on inheritances. In a research report you can read here, GSI contributor Danielle Zanzalari, PhD. documents the enforcement of this tax has wide ranging implications for residents, businesses and our competitive standing.

The New Jersey law states that if one dies and wants to leave money to their sibling or niece/nephew, the beneficiary must pay an inheritance tax on the value. However, if the relationship to the decedent is different, such as a child, then no inheritance tax may be levied.

Among the key findings of the report, Dr. Zanzalari writes that the Inheritance Tax:

- Creates economic inefficiencies for individuals
- Incentivizes relocation for retirees to tax friendly states
- Disproportionally impacts individuals that are not wealthy
- > Is an unreliable revenue source for the state

"Often times people think that an inheritance tax only hurts the rich, but in reality, an inheritance tax creates economic inefficiencies that hurt the young and elderly, many of whom are not wealthy at all," noted Dr. Zanzalari.

Following opening remarks from Dan Clifton, Managing Director & Head of Washington Research at Strategas on the 2022 Economic and Political Landscape, the discussion

soon turned to "bread and butter" issues of opportunities for job creation and finding the optimal path to secure, affordable power sources for New Jersey's 9 million citizens. The event was concluded with a panel discussion on the outlook for key issues in our state in 2025.

## RESTORING NEW JERSEY'S BUSINESS CLIMATE

In New Jersey we've got a lot of work to do to compete for jobs, residents and investment. That was the consensus of GSI's virtual forum on October 26th with the New Jersey Society of CPAs "Economic Earthquake Pennsylvania's Dramatic Tax Cuts & What It Means for New Jersey" where we discussed the story of neighboring Pennsylvania's massive tax cuts and what it means for our state.


During the Summer, Pennsylvania enacted a bipartisan plan to cut its business taxes, currently 2nd highest in the U.S. behind New Jersey, by 50% over the next decade. That reduction will place Pennsylvania among the 10 lowest in the country as well as the lowest in the Northeast.

The virtual forum brought together policy leaders from Pennsylvania and New Jersey to discuss the story behind the Keystone State's plan to cut business taxes and what it means for New Jersey's economy.

In a discussion moderated by GSI's Regina Egea, attendees heard from Pennsylvania State Senator Ryan Aument, who is widely credited as the driving force behind the tax cuts and Elizabeth Stelle, Director of Policy Analysis for the Commonwealth Foundation, who analyzed the impact on that state's economy.

Looking back at home here in New Jersey, Jason Rosenberg, CPA, a Garden State resident and Principal at Withum, discussed how our state's onerous tax burden has already caused many businesses to leave the state and for those who remain to reassess their investments here. State Senator Mike Testa, a member of the Senate Budget Committee, discussed how the state's poor business climate directly hurts businesses and the economy of his district.

In 2023, look for much more from GSI on this issue and how New Jersey can improve its business climate.

### A LOOK AHEAD TO GSI IN 2023



With all 120 seats in the New Jersey Legislature on the ballot as a result of decennial redistricting, we expect issues of affordability, economic growth and our state's competitiveness to be on the top of the agenda. We will also be working to tackle our state's affordable housing crisis and efforts to improve our infrastructure, as well as hosting our regular policy forums and educational efforts on the state budget and economic issues that should concern every citizen.
